The Annual Fishing Permit, the boat decal, and a copy of all regulations will be forwarded to you within two weeks. Additional application forms may be found at the Lake Cohoon Fishing Station, the Suffolk Visitor's Center, and Dashiell's Showroom in Suffolk. The application form may also be downloaded via the City website. The Annual Fishing Permits may be purchased in person at the Department of Public Utilities office in the Portsmouth Municipal Building (1st floor). 2012 FISHING REGULATIONS

(PARTIAL LIST)

- All Persons on the reservoirs must have an Annual or Day permit in their possession.
- Fishing is only allowed from civil sunrise to sunset. Fishermen should be prepared to leave the boat ramps by sunset!
- Boat motors may not exceed 10 HP output.
- All boats being operated within the reservoirs must be in compliance with all applicable State Registration, Equipment, and Safety requirements. This includes providing a wearable life vest (PFD's) for each boat occupant.
- Children under sixteen years old must be accompanied by an adult in the boat and must wear a life vest at all times. Children under 12 may fish free when accompanied by a paying adult.
- Boating in a reckless manner is a violation of City and State regulations. Reckless boating includes excessive speeds or wakes.
- State fishing regulations and catch limits must be adhered to in Portsmouth's reservoirs.
- Regulations may be enforced by Game Wardens, Police Officers, and Portsmouth Utility Employees.
- Unattended boats not displaying a current year's decal will be subject to confiscation by the Department and the collection of a \$50.00 impoundment and return fee.
- The use or possession of alcoholic beverages and/or firearms on the lakes or watershed areas is prohibited.
- Any persons who cause or allow any act which affects the quality or purity of the lake's waters, or is guilty of illegal or dangerous acts will be barred from the lakes. Such persons may be subject to civil and/or criminal penalties and have all fishing privileges and permits revoked.




FISHING PERMIT INFORMATION

The City of Portsmouth allows fishing in the City's reservoirs located within the City of Suffolk by the issuance of Annual Fishing Permits. All fishermen over the age of 16 must also have a valid State or City of Suffolk fishing license. An annual permit allows the permit holder and guests in their company fishing privileges within the City of Portsmouth owned reservoirs. These reservoirs are **Lake Cohoon, Lake Kilby, Lake Meade, and Speights Run**. Launch ramps providing public access to Lake Cohoon and Lake Meade are located at the Lake Cohoon Fishing Station on Pitchkettle Road. Speights Run has a boat ramp at the dam on Turlington Road. **The Lake Kilby reservoir does not have a public access facility.** Shore fishing is restricted to the area of the Lake Cohoon Fishing Station.

Annual Permit fees are as follows: **Non-residents, \$40.00; Senior Citizens, (Age 62 or above) \$20.00 Portsmouth residents; \$20.00; Portsmouth resident Senior Citizens, \$10.00.** Permits include the issuance of a decal to be placed on the starboard bow (right front) of the permit holder's boat. **Boat Decals** allow boats to be moored at the Lake Cohoon Fishing Station or at private piers. Second boats on city properties will require the purchase of an additional Annual Permit. Boats which are left unattended are at the owner's risk. Annual Permits issued this year will expire on April 15, 2013.

Persons who do not desire to purchase Annual Permits may purchase **Day Permits** at the Lake Cohoon Fishing Station. Boat rentals, rental trolling motors, PFD's, bait, tackle, snacks, and beverages may also be purchased at the Fishing Station.

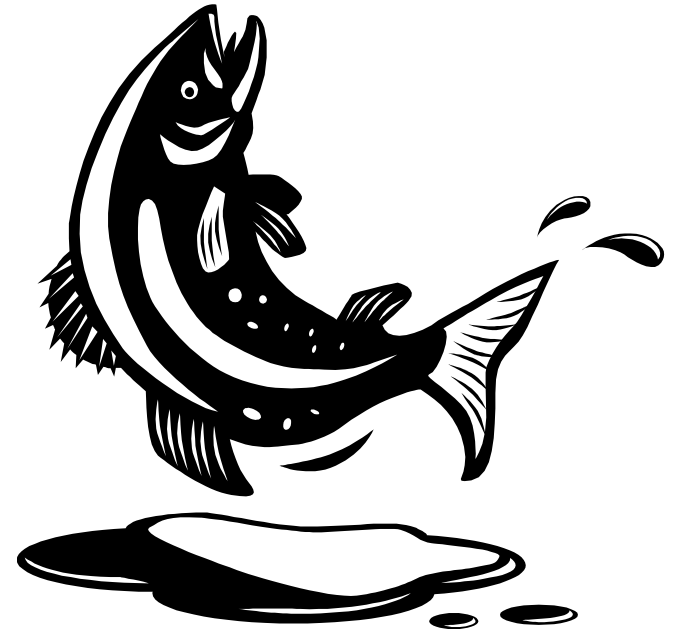
